Objectives

Sustainable Operations

- Comply with all relevant environmental regulations and mandatory standards applied to the company's operations.
- Achieve 100% renewable energy across operations.
- Collect and monitor energy, carbon, water, and waste data, where relevant.
- Reduce energy usage and associated greenhouse gas emissions from facilities through efficient operational strategies, equipment and renewable energy where feasible.
- Apply green building standards to new and existing facilities.
- Implement waste reduction programs.
- Implement water reduction measures at sites located in water-stressed regions.
